#### DIRECTIONS TO PURINA FARMS HERDING FACILITY

**I-44 From East or West** – Take Gray Summit Exit #253 (Hwy 100 E). Turn north on Hwy 100 E. Go approximately  $\frac{1}{2}$  mile to County Road MM & turn left (at Dirt Cheap gas station). Entrance to Purina's herding field is a little less than a mile on the left. If you reach the formal entrance to Purina Farms, you've gone one driveway too far.

- In order to have ASCA trial points tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum "Service" membership is required). ASCA membership does not need to be maintained in subsequent years. It will be the responsibility of the owner to identify previous ASCA qualifying scores earned when applying for a Tracking Number. A Tracking Number Application is attached to this premium or it can be download at https://asca.org/wp-content/uploads/2022/06/qtsvcapp.pdf.
- Use only ASCA entry forms that require exhibitor's or parent/legal guardian's signature on the back.
- Correct amount <u>must</u> accompany entry form. Any checks returned for insufficient funds will be considered a void entry. There is a \$25 service charge for each returned check. If entries are resubmitted, payment must be in the form of cash, Money Order, or Cashier's Check, or PayPal.

EMAIL ENTRIES WITH PAYPAL PAYMENT WILL BE ACCEPTED AS FOLLOWS:

- Entries must be submitted on official ASCA entry forms. <u>Stockdog Program Rules (asca.org)</u>
- Forms must be filled in completely and signed. Please type or write legibly.
- Email completed forms to <u>dbettis@swbell.net</u>
- Payments should be made via PayPal to <u>GASC1995@gmail.com</u>.
- For payments to be accepted, please include your **name** and the **events** you are submitting payment for. <u>Payments without</u> <u>proper identification will not be accepted.</u>
- Please add a 5% processing fee when submitting your payment. This fee must be included at time of payment to be accepted.

For example: Jane Doe wishes to submit \$75 of entry fees via PayPal for Conformation. She would email her completed signed form to the show secretary and send \$78.75 (fees plus 5%) with the note "Jane Doe – Stockdog Trial Entries". If entering multiple events, please note each event. "Jane Doe – Farm Trials - 2 runs; Stockdog Trials - 4 Cattle/4 Sheep/4 Duck Runs.

Upon receipt of <u>BOTH the properly completed entry form and the PayPal payment confirmation (with fee)</u>, your entry will be processed.

- Entry fees will not be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire and/or dangerous
  weather conditions, acts of God, public emergencies, acts of a public enemy, strikes, or other causes beyond the control of GASC.
  Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from
  competition by the Trial Committee.
- Run order will be determined by random drawing the week before the trial. Gate entries will run last.
- Entry fees will not be refunded after the pre-entry deadline, unless there is a waiting list. Pulled entries are not considered withdrawn UNTIL you have received written confirmation from the Course Director. Additional entries will be made from a waiting list established in order of receipt. Additions will be made prior to the start of the trial and are at the discretion of Gateway ASC. Fees will be refunded to the original entrant before close of entries only if a replacement dog is entered in place of the absent dog.
- Dogs entered in the Novice Handler Division **may not** compete in any other division on the same class of livestock on the same day. Dogs entered in the Junior Handler Division may compete in any other division on the same class of livestock on the same day. Scores from the Junior Handler and Novice Handler Division are not eligible toward certification or special awards (i.e., Started/Open/ Advanced, Sheep/Cattle/Ducks, Weekend High Combined, etc.).
- All dogs, whether competing for certification or not, MUST enter in the Started Division & progress through the Advanced Division.
- Should the entered dog injure stock, owner will pay for veterinarian services. If the injury is severe, owner will pay the market value
  of the stock (see, ASCA's Agreement on the back of the entry form). Market value of the stock has been determined to be \$1,000
  or current market value (whichever is greater) for cattle, \$175 for sheep, and \$35 for ducks.
- Other Breeds All herding breeds and mixes thereof listed as eligible to compete in ASCA Stockdog Trials. Non-ASCA registered Aussies are considered "other breed." See Appendix 1, ASCA Stockdog Rules and Regulations.

## Notice to Exhibitors (Continued)

- Training devices (mechanical and/or electrical) will not be permitted on trial grounds.
- Bitches in season are permitted and will run in catalog order.
- Tied scores within the same class will be broken by time or rerun of any part of the course. This is determined by the judge's authority and at his/her discretion.
- Each owner/handler is responsible for their dog(s). Dogs must be confined or on lead at all times, except when competing. Dogs are <u>not</u> allowed to run loose on the trial site.
